

A Proclamation from the Elders:

There can be no 'reconciliation' with the killers of our children!

The Catholic, Anglican, and United churches are banished from our lands!

We are traditional elders of the Ahousaht, Nuu-Chah-Nulth, Cowichan, Squamish, Sto:lo, Tsilhqot'in, Cree, Metis, Anishinaabe-Ojibwe, Haudenosaunee, Mohawk, Huron, Mi'kmaq, and Dene Nations. We speak by the authority of the Great Law.

All of us are survivors of a war of extermination waged against us by the Catholic, Anglican, and United churches of Canada. These churches ran the genocidal 'Indian residential schools' that killed over 60,000 of our children. They got away with their mass murder with a few words of "apology". And they are still trafficking and murdering our children in partnership with the Canadian government and China.

Therefore, we Elders assembled at Council Fire proclaim that these churches, their priests, and their officials are now and forever banished from our nations across Canada. They must immediately depart or face arrest by our Peacekeepers.

We also reclaim their lands, their church buildings, and the wealth they stole from us as lawful reparations for their slaughter of our people. We will be enforcing this Proclamation in reclamation ceremonies at these churches.

We authorize all people to assist us in evicting these churches from our nations and seizing and occupying their buildings for the welfare of all the people.

We take this action with our white brother Eagle Strong Voice/Kevin Annett, the legal agent of traditional Squamish Siem Kiapilano, who evicted these churches from Vancouver on March 4, 2008. (B.C. Supreme Court Docket No. S036483). We grant Kevin and his deputies the authority to enforce this Proclamation.

Issued by us at Council Fire on Tuesday, September 30, 2025 under the Great Law.

Don't be duped by ReCONciliation! The Slaughter Continues!
