## A Matter of National Security and Public Urgency

If you review the records of the 2009 H1N1 "outbreak" and vaccination campaign, you will conclude the facts prove fraud, official malfeasance, organized crime, and genocide operating under the guise of "public health" within a trust organization established by David Rock-

efeller called "Partnership for New York City" involving the U.S. Federal Government.

This subject is a matter of *extreme* urgency, threatening national security, thus demanding the immediate scrutiny of lawmakers, justice department officials, and you.



WHO is Controlled by the Rockefellers' "Trust"

It is a well-established fact that "outbreaks" have been "laboratory sourced." The 1977 outbreak of "swine flu"—extinct for twenty years—suddenly re-emerged following the suspicious unexplained 1976 outbreak at Fort Dix, New Jersey of this strain. The subsequent deadly swine flu vaccination program that followed this "military experiment," was fueled by media-driven fear. The "outbreak" came from a refrigerator according to experts published in the *New England Journal of Medicine* (July 16, 2009; Vol.361:279-285) and elsewhere. A similar November 1977 sudden reemergence of this Influenza A H1N1 strain in the former Soviet Union is best explained by the National Cancer Institute's 1978 publication titled *Special Virus Cancer Program* (Library call number: E20.3152;V81/977 and 78-21195). This report revealed the June 15, 1976 contract (N01-CP-6-1047) with the American Type Culture Collection to supply "virus materials . . . to investigators throughout the world" via a "US-USSR Agreement" (a dangerous breach of Cold War national security). (See: EXHIBITS 2-3.) Virus materials cited in this document included numerous infectious agents including influenza, parainfluenza, and even laboratory recombinations of influenza with acute lymphocytic leukemia viruses that might spread quick acting lymphatic cancers by sneezing. (See: EXHIBIT 4.)

## COVERT OPERATIONS

The April, 2009, "outbreak" of the H1N1 "swine flu" is, like the 1976 Fort Dix and 1977 general "outbreaks," highly suspicious according to genetic analysts and leading virologists. The rapid mutation rates of the novel agent circulating and feared as the 2009 "swine flu" strongly suggests a laboratory source, clearly intentionally released.

Making it more difficult to understand what is ongoing in flu labs, according to EXHIBIT 5, World Health Organization (WHO) officials developed new terminology to describe viruses used in vaccinations, gene therapies, and advancing biotechnologies. The new terms "reference materials," "biosimilars," "data packages," and "mock-up files," each designate viruses and/or viral materials including gene sequences that cause disease and immune system reactions.

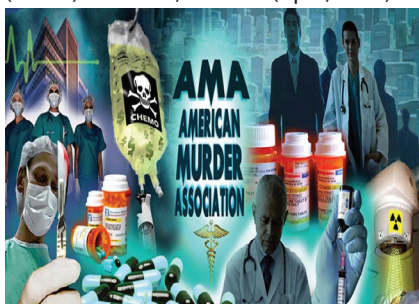
## DANGEROUS INGREDIENTS

The WHO is controlled by Rockefeller money. WHO officials now direct US government officials who falsely claim these vaccines are "safe and effective." This is a lie because side effects that occur more than 6 weeks after injections are excluded, including the vast majority of vaccine illnesses and deaths. The ingredients in all flu vaccines are poisonous and potentially deadly.

What's in a flu shot? Egg proteins and viruses linked to autoimmune diseases and cancers; Gelatin and Polysorbate 80 (Tween80): known to cause allergic reactions and anaphylaxis; Formaldehyde: known carcinogen, used to preserve corpses; Triton X100: a strong detergent; Resins: known to cause allergic reactions; Gentamycin: an antibiotic; Thimerosal: Mercury linked to autism, Alzheimers', MS, and Parkinson's Disease—far deadlier when injected into your blood than when you eat tuna fish; Aluminum neurotoxin.

## THE MEN BEHIND THE H1N1 CIRCULATING FLU

WHO officials in charge of developing influenza vaccines, Dr. James Robertson and Dr. John Wood, of the National Institute for Biological Standards and Control (NIBSC) in the UK, testified (April, 2006)

that "if a pandemic is imminent, . . . A stockpile of live vaccine, . . . could be used to prime the population in advance . . ." This is what the Mexican swine flu outbreak of 2009 did—it primed the public with a now circulating virus.

These doctors responsibilities include the control and standardization of influenza vaccines worldwide. They oversee the serological testing of blood from vaccine trials; the preparation and distribution of influenza viruses to vaccine manufacturers; and the coordination of virus strain selections (used by governments worldwide for their "vaccine pipelines").

Dr. Robertson also testified that "there is a lack of vaccine research in the UK compared with the U.S.," and that he and Dr.

Wood "consider that pandemic vaccine development in the EU has been slow due to limited public funding. This is in contrast to the situation in the USA. Dr. Wood told the group that the NIBSC collaborate with the vaccine industry . . . The EMEA have helped to persuade industry to invest in pandemic vaccines with the introduction of the mock up files (i.e., new "live" genetically engineered viruses) and by waiving the regulatory fees . . ."

The European Medicines Agency (EMA) is a decentralized body of the European Union with headquarters in London. Its main responsibility is, according to its website, "the protection and promotion of public and animal health, through the evaluation and supervision of medicines for human and veterinary use."

## NATURAL OR MAN-MADE? THE MEDIA LIES

When the Mexican Swine Flu 2009 "outbreak" occurred in mid April, 2009, first in the United States in two unrelated children living approximately 100 miles apart in southern California, then soon after in Mexico among people who had not been exposed to these two children, foul play was a most reasonable explanation, especially since this unique virus held genes from avian, swine, Spanish, and regular flu strains -- unprecedented in the history of "natural selection" and evolution of the species.

Occam's Razor analysis holds that, "Of several acceptable explanations for a mysterious phenomenon, the simplest is preferable, provided that it does not contradict the observed facts."

U.S. federal officials overseeing "bio-preparedness" against this mutant H1N1 flu, including vaccinations and quarantines, say this outbreak occurred "naturally," but neglect history and epidemiology. These so-called "experts" regurgitate the same lame explanation of "somehow" and "somewhere" bird, pig, and 1918 Spanish flu viruses mated, curiously synchronously with the press releases heralding the new biotechnology to produce vaccines alleged to be safe and effective against this new H1N1 recombinant.

Alternatively, the following substantial evidence indicts David Rockefeller, celebrated federal agents, agencies, and vaccine makers that control the main-

stream media, and the practice of medicine, in an organized criminal conspiracy to profit by generating and promoting this pandemic. This is classically called a "false flag" pandemic.

A "false flag" operation is a covert operation conducted by governments, corporations, or other organizations, designed to appear as if they are being carried out by other entities, in this case NATURE!

Only days *before* the media's first reported swine flu cases in April, 2009, Novavax Corporation, partnered with the General Electric (GE) company that co-owns NewCo with media mogul Rupert Murdoch, issued press releases generating widespread fear that H5N1, the deadliest avian flu, was part of this H1N1 virus when it was not.

## WHO IS MAKING THE MONEY?

America's most powerful news media consortium publicized Novavax's (Novartis's) "Johnny-on-the-spot" H5N1 and H1N1 vaccine research in collaboration with CDC officials. They alleged their vaccine cross-protected against this unprecedented recombination of flu strains, even IF it contained H5N1. (See EXHIBIT 7.)

According to Dr. Robertson's testimony, Novavax received its "biosimilars" through CDC Influenza Branch director, Ruben O. Donis, and Dr. Rick Bright. Dr. Bright previously worked with Dr. Donis at the CDC. In April, 2009, Dr. Bright was Novavax's Vice President of Global Influenza Programs.

The "false flag" Mexican outbreak caused Novavax's stock to soar. Novavax's CEO, Rahul Singhvi, and his previous corporate affiliate, Merck & Co. (CSL) that manufactures the pneumonia and H1N1 vaccines, both profited heavily from the fright generated by media coverage and declared advancing pandemic.

No group in the world other than this Anglo-American vaccine "pipeline," with its faucets at the NIBSC and CDC, could supply anyone with the strains and genes associated with this "triple reassortant" virus. The media moguls' gross conflicting interests benefiting their companies' vaccine sales is obvious.

Now get this! Thomas H. Gloer is the CEO and director of the Thomson Reuters Corporation (TRC) that partnered in David Rockefeller's biotechnology trust called "Partnership for New York City" (PFNYC). Thomas H. Gloer is also a **Merck & Co. Director since 2007**, according to the Merck company website. (See: EXHIBITS 8 and 9.)

Merck & Co., in April 2007, negotiated a buy-out of CSL Co.—the major Australian H1N1 flu vaccine maker that did the testing on pregnant women, babies, and children. Incredibly, the two clinics wherein these H1N1 vaccine experiments were conducted were both controlled by the largest media mogul, Rupert Murdoch, and his family.

Rupert Murdoch is Co-Chairman with David Rockefeller and Lloyd Blankfein (of Goldman-Sachs), directing this—the world's most powerful drug ring—a biotech trust that includes the New York State Government and the U.S. Federal Government as "partners." Both governments purchase vaccines from other partners in this organization, the PFNYC.

## CHARTERED BY THE QUEEN OF ENGLAND

The PFNYC, according to their website, was "initially formed by merging two organizations: the New York Chamber of Commerce and Industry, and the New York City Partnership. The New York Chamber of Commerce was founded on April 5, 1768, by a group of merchants whose purpose was to encourage business and industry, ... the Chamber remained sufficiently loyal to the [British] Crown to receive its royal charter in 1770 from King George III, ... After the [Revolutionary] war, ... the New York State Legislature ... confirm[ed] their original charter [on April 13, 1784] ... entitled 'An Act to ... Confirm the Rights and Privileges Thereof' ..."

Following in the tradition of three generations of Rockefellers, the website states, the Chamber grew to become the PFNYC,

founded in 1979 by David Rockefeller. "Under Rockefeller's vision, the Partnership would allow business leaders to work more directly with government and other civic groups to address broader social and economic problems in a 'hands on' way. In 2002, the New York City Partnership and Chamber of Commerce became the Partnership for New York City. ..." (See the PFNYC website: (<http://www.pfnyc.org/history.html>))

Rupert Murdoch is Co-Chairman, with Honorary Co-Chairman David Rockefeller, in the PFNYC. Rupert Murdoch's mother, Elisabeth Murdoch is Dame Commander of the Order of the British Empire, a Companion of the Order of Australia, which is an order established by Queen

Elizabeth II. Elisabeth Murdoch administers the Royal Woman's Hospital in Victoria, Australia, the vaccine research center testing and promoting the swine flu vaccines and drugs for pregnant women and babies.

## RUPERT MURDOCH'S TIES TO ROCKEFELLER & FLU VACCINES

Another major "player" in PFNYC is Jerry Speyer, owner of the Rockefeller Center. He is chair emeritus of the PFNYC. He is Chairman of Tishman Speyer, former



Chairman of the Board of Directors of the Federal Reserve Bank of New York; chairman emeritus of Columbia University; and a member of the David Rockefeller-directed Council on Foreign Relations (CFR) — 3600 of the wealthiest and most influential persons in the US — that directs government action including those that concern overpopulation and "bioterrorism".

Nelson Rockefeller's protégé, Dr. Henry Kissinger, is also a highly influential member of the CFR. His Kissinger Associates, Inc. is Merck & Co.'s leading management consulting firm.

Merck & Co. is the world's largest vaccine and drug maker. The company not only profits from flu frights and pandemics by

sales of Pneumovax and CSL's H1N1 vaccines, it is also responsible for having spread the AIDS virus, HIV, through contaminated hepatitis B vaccines according to research published in the peer reviewed scientific journal *Medical Hypotheses* (Volume 56, Issue 5, Pages 677-686) by this author.

Further evidencing an Anglo-American conspiracy to commit iatro-genocide using vaccines, a CSL Biotherapies report (See: EXHIBIT 10.) proves this firm operates one of the world's largest influenza vaccine manufacturing facilities for supply to Australia and global markets. This facility is based in Parkville, Victoria. This document explains the vaccine manufacturing process and the exclusive supply of viruses for vaccine research and manufacture from the WHO or the CDC, thusly:

## AUTOIMMUNE DISEASES CAUSED BY VACCINES

*"The first step in making the influenza vaccine is preparing a 'seed' virus. This is a safe form of the influenza virus, which can be grown in hens' eggs to produce the vaccine. Preparation of the seed takes around 3-4 weeks following receipt of a potential candidate virus from international health bodies such as the World Health Organization (WHO) or the U.S. Centers for Disease Control and Prevention (CDC)."*

This means the CDC's Dr. Donis shipped Novavax's former CDC asset, Dr. Rick Bright, his H1N1 viruses that implicate this "pipeline" in a conspiracy to commit humanicide.

Besides Murdoch's mother's hospital — CSL's primary H1N1 swine flu vaccine testing site — is the Rupert Murdoch Children's Research Institute (MCRI) of Victoria, Australia, controlled by his daughter-in-law, Sarah Murdock. Here children and babies are experimented upon.

The Associate Director of Clinical Development for vaccines at CSL is Dr. Michael Greenberg, who directed the vaccine studies on babies at the MCRI, according to their website. (See: EXHIBIT 10.) Dr. Greenberg joined GlaxoSmithKline in 2005, and CSL in 2009, further evidencing Rupert Murdoch's conflicting media interests with, besides CSL and Merck & Co., SmithKline.

Historically, vaccinations have been discouraged as "elective procedures" for pregnant women. Research proving a causal link between mercury added to vaccines and neuro-developmental illnesses in children has been grossly suppressed by governing officials and the media wielded by these "players." Developing fetuses are even more hypersensitive to mercury in these vaccines.

These associations and revelations indict these persons in the most heinous genocide the world has ever seen. Lying to pregnant women, making them first recipients of these vaccines that deliver deadly and disease-inducing agents, is despicable beyond words.

The greatest vaccine damage is caused by "auto-immune" diseases. These are caused by foreign proteins and genetic materials injected into human bodies. This intoxication reaction is criminally neglected by organized medicine. The poisoning creates "antigenic complexes" to form in your body causing white blood cells to attack your body where these antigenic complexes occur. ## POPULATION REDUCTION VIA VACCINATIONS

In September 2009, babies and children were being recruited by the MCRI, for “a pandemic H1N1 swine flu vaccine trial” in Melbourne wherein “about 100 Victorian children aged 6 months to eight years” were selected for study in collaboration with the University of Melbourne and Federal Government of Australia.

This historic record evidencing fraud and ongoing genocide within the medical and public health sectors of the WHO-directed US, UK, and Australian governments is best reconciled by medical sociologist Stephen Kunitz's 2000 report in the *Journal of the American Public Health Association* (Vol. 90, 10:1531-39) wherein he concluded wherever Anglo-American multi-national corporations travel, so goes genocidal depopulation of native people. Could this targeting of native people now extend to populations in general? Obviously so.

Barack Obama's Environmental Advisor, Van Jones, resigned for signing a petition in 2004 asking for an investigation into those implicated by foreknowledge in the September 11, 2001, World Trade Center “terrorist” attacks, including PFNYC “partner” and property manager Larry Silverstein.

This infamous place is now home to the PFNYC.

It must be understood that New York's United Nations (UN) building was constructed using Rockefeller money. The UN's WHO was established by the Rockefeller family's foundation in 1948 -- the year after the same Rockefeller cohort established the CIA. Two years later the Rockefeller Foundation established the U.S. Government's National Science Foundation, the National Institute of Health (NIH), and earlier, the nation's Public Health Service (PHS).

It must be further understood that England's colonialism has transitioned into neocolonialism, commonly called globalism. British influence has evolved most apparently and consistently with financial support by the European banking community led by the Rothchild family that has, according to geopolitical and economic historians, heavily financed Rockefeller family interests since the late 1800s. Vaccination campaigns have been part of this global conquest agenda.

It should be noted that Barack Obama's current “Science Czar,” John Holdren, endorsed sterilization through vaccinations in his co-authored book, *EcoScience* in 1977.

Population reduction via vaccinations for eugenics and genocide has many earlier examples:

In 1968, James V. Neel et al., conducted genetic studies using the deadly Edmonson B measles vaccine. This was funded by the Rockefeller Foundation and U.S. Atomic Energy Commission that maintains obvious ties to British commissions. This vaccine caused the death of several thousand Yanomami natives in Brazil. Lesser-known examples of vaccine-induced genocides involve the Lyme vaccine, the 1976 Swine Flu vaccine, the polio vaccines that spread cancers, and the hepatitis B vaccines that triggered AIDS as published by this author in 2000 in the journal *Medical Hypotheses*. The Tuberculosis skin testing genocide ongoing in Hawaii, as published in *Medical Veritas* in 2007 (4:1505–1509), is another example.

## EUGENICS, GENETICS & BLOOD BANKING IN NYC

Before Hilter called it “racial hygiene” it was called “eugenics.” This program began at Rockefeller and Carnegie funded Cold Spring Harbor Labs in New York. Eugenics investors in genetic engineering and

“population management” extended their institutional control over Nazi Germany by advancing “showers” with IG Farben and through the Bayer Corporation. Holocaust victims believed they were taking showers for “public health” and “disinfection,” much like we are told vaccines provide today. Later eugenics “experiments” included the Tuskegee Syphilis Study administered on behalf of Rockefeller interests by the U.S. Public Health Service (PHS).

The man that directed Tuskegee from the CDC was Dr. David Sencer, who also directed the 1976 Swine Flu Vaccination campaign. Later he administered the transmission of HIV/AIDS through contaminated blood supplies from New York City on behalf of the Rockefeller blood banking industry.

This is not “conspiracy theory,” but a certifiable “conspiracy reality” sustained by a “conspiracy of silence” afflicting the media and thereafter the American people. It is a sociopolitical psychopathology preventable only by the free exercise of our First Amendment right to a free press. Given the manner in which these devil-doers control the media, however, including the medical scientific media, America's founding fathers' objective to secure civil rights and happiness by way of a free press has been criminally subverted.

In the United States, the NIH, PHS, and the American Academy of Pediatrics (AAP) that sets the vaccine schedule, have incestuous relationships with “Big Pharma” and its ring of organized PFNYC criminals. These agencies and officials

minimize vaccination risks, deny vaccine ingredient toxicities (e.g., mercury and the vaccine additive MF59 [Novartis/CHIRON] or ASO2-4 [Glaxo-SmithKlein] containing squalene and IL-2); and promote vaccination policies ignoring reason and legitimate precautions based on science.

The reach and impact of the PFNYC obviously taints geopolitics, economics, and vaccine science globally. According to Kathryn S. Wylde, the President and CEO of the PFNYC since 1982, who was appointed to the Board of Directors of the Federal Reserve Bank of New York in 2009, the PNYC encourages foreign investment, particularly from China, thusly:

*“The announcement of the China Center is a step toward economic recovery for New York. The Vantone Group's commitment to helping New York become the western headquarters location for the increasing number of global businesses coming out of China is extremely important to our city's future as a global capital of business and finance.”*

The “China Center” lease is administered by Silverstein Properties, Inc. a “partner company” in the PFNYC. It is owned by Larry

A. Silverstein, the infamous real estate tycoon, who cashed in on his timely \$3.2 billion lease of the World Trade Center property seven weeks before “9-11” happened in 2001.

The subsidiary of GE Capitol, Industrial Risk Insurers company, paid some of Silverstein's alleged loss of \$7 billion needed to reconstruct the new World Trade Center.

## ZUCKERMAN PROMOTED DISASTROUS LYMERIX VACCINE

Mr. Silverstein stated during an interview that he ordered Building-7 be "pulled" before it came down, a reference associated with demolition jobs. Thus, these PFNYC partners may have murdered 3,000 people in 8 seconds during "9-11." If so, imagine how many people they might kill during flu season this year?

The Mortimer B. Zuckerman Research Center is the namesake created by the PFNYC partner who is the chairman and co-founder of the publicly traded Boston Properties. The Center is associated with the Memorial Sloan-Kettering Cancer Center and Rockefeller University. Zuckerman is also Editor-in-Chief of *U.S. News and World Report* and publisher of the *Daily News*. He is also member of the Council on Foreign Relations largely

directed by honorary PFNYC chairman, David Rockefeller. His estimated net worth is \$2.8 billion. Mr. Zuckerman, a candidate for U.S. Ambassador to Israel, and a leading financier of the American Lyme Disease Foundation that heavily promoted SmithKline company's disastrous Lyme vaccine. This vaccine was pulled from the market following hundreds-of-thousands of reported cases of recipients suffering post-vaccination symptoms of Lyme disease.

Another major promoter and endorser of SmithKline's toxic and terminated Lyme disease vaccine is the U.S. Federal Government's National Institute for Allergies and Infectious Diseases (NIAID) Director, Anthony S. Fauci, upon whom Mr. Zuckerman bestowed an "America's

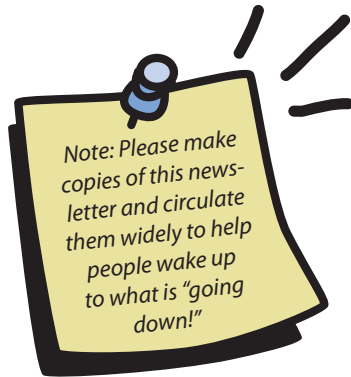

## CONFLICTING INTERESTS - GOVERNMENT AND INDUSTRY

The SVCP was speciously investigated in 2002 by the United States General Accounting Office (GAO-02-809R Origin of AIDS Virus), that concluded its



fraudulent study on June 17, 2002. The investigation was forced by persecuted, and later incarcerated, Ohio Congressman, James A. Traficant, Jr.

The SVCP is undoubtedly linked to the origin of HIV/AIDS as evidenced by its documentation. This incriminates HIV co-discoverer, Dr. Robert Gallo, and his employment with the National Cancer Institute overseeing Litton Bionetics's contract (71-2025) titled, "Investigation of Viral Carcinogenesis in Primates." This indicting document relates to the Merck company SVCP contract (71-2059) "Oncogenic Virus Research and Vaccine Development," directed by Dr. Maurice Hilleman. (See: EXHIBITS 12 and 13.pdf)

Before his death, Dr. Hilleman, Merck & Co's vaccine chief, stated that he brought the AIDS virus into North America in contaminated monkeys destined for vaccine research at Merck & Co. Litton Bionetics also exclusively administered the NCI's facilities at Fort Detrick, MD, at the time Litton supplied chimpanzees were used by the CDC, FDA, NIAID, and the Merck & Co. to produce four subtypes, one each, of hepatitis B virus vaccines for testing on: 1. homosexual men in New York City, 2. African villagers in Zaire/Congo and Uganda, and 3. Willowbrook State School mentally retarded children on Staten Island in New York. The latter studies

## SUPPRESSED ORIGIN OF AIDS THESIS

were conducted under a U.S Army contract with the New York University Medical Center's Dr. Saul Krugman. (See: EXHIBIT 14.)

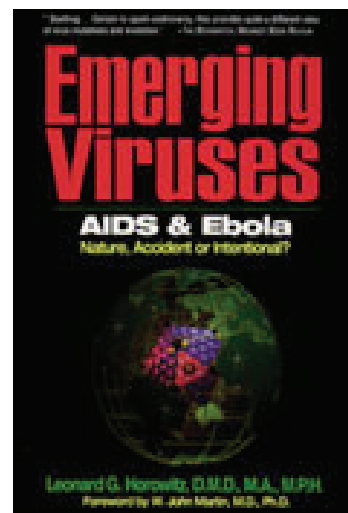
Thus, the leading HIV/AIDS institute in the US, the NIAID, directed by the leading American infectious disease official, and HIV/AIDS czar, Dr. Anthony Fauci, has grossly and criminally neglected compelling documents and solid science that indicts Merck, the FDA, CDC, and his own NIAID. ## DR. FAUCI, NIAID DIRECTOR IMPLICATED IN GENOCIDE

Dr. Fauci is also co-patent holder (No. 5,696,079; Dec. 9, 1997) on a vaccine ingredient, an adjuvant, called IL-2, short for Interleukin-2. This is described as being central to gene therapies and the

future of “geneto-pharmaceuticals.” The Assignee on this patent is: The United States of America as represented by the Department of Health (Washington, D.C.), but the Associated Press reported that the inventors share in licensing deals struck with private manufacturers. Fauci received at least \$45,072.82 in royalties since 1997 when the government licensed IL-2 to chemical company giant, CHIRON Corp. Fauci allegedly donated his royalties to charity to avoid conflicting interest charges. But he admitted it was his decision to withhold disclosures to test subjects during drug trials using IL-2 under his supervision.

Thus, Dr. Fauci’s co-patent filing evidences entrepreneurship of the U.S. Federal

Government, through its Department of Health, at the expense of taxpayers, in this valuable biotechnology now licensed to CHIRON Corporation, makers of the swine flu vaccine adjuvant additive MF59 with squalene., that additionally contains “proprietary” ingredients that probably includes IL-2. (See: EXHIBIT18.)

There is substantial scientific evidence, some of which was addressed by the United States Congress during its investigation into Gulf War Syndrome, that squalene adjuvant, with IL-2 or not, is implicated in poisoning masses of military personnel who received the anthrax vaccine. This additive in the majority of H1N1 flu vaccines is expected to cause horrific side effects in people worldwide.

## DEADLY INGREDIENTS, DEADLY VACCINES

Moreover, regarding the history of IL-2, on Monday, Oct. 6, 2008, Dr. John Niederhuber, the director of the NCI, told Lawrence K. Altman of the *New York Times* that Dr. Robert Gallo “was instrumental in every major aspect of the discovery of the AIDS virus.” He added: “Dr. Gallo discovered interleukin-2 (IL-2), an immune system signaling molecule, which was necessary for the discovery of the AIDS virus, serving as a co-culture factor that allowed the virus to grow.” Dr. Fauci added to this, “There’s no doubt that Bob Gallo made enormous contributions to AIDS research.”

The world of science is aware that IL-2 is the “common denominator” among immune system functions, and can cause severe side effects. Yet, IL-2 has been

recommended for increasing numbers of vaccine adjuvants. (See: EXHIBITS 19 and 20.)

New research on Dr. Fauci’s IL-2, apparently in the “proprietary” formula of swine flu vaccine adjuvants, shows IL-2 caused no benefit whatsoever stimulating the immune systems of 5,800 subjects at a cost of \$85 million. CHIRON and taxpayers paid the tab.

CHIRON’s MF59 adjuvant used in the 2009 swine flu vaccines by GlaxoSmith-Kline and Novartis, and Merck’s Lymerix vaccines, contains squalene along with Dr. Fauci’s IL-2, preferred by the drug trade due to its toxic side effects as this makes money for shareholders in Big Pharma.

Regarding squalene, according to Dr. Andrus Laursen, the amount of squalene in the swine flu vaccine made by Glaxo-SmithKlein is far more concentrated than in the anthrax vaccine implicated in producing Gulf War Syndrome in hundreds-of-thousands of military personnel.

In essence, even though the US Congress investigated and condemned squalene’s use in vaccines as being deadly, and harshly criticized the vaccine developers that used it, today it is still being used by most of the H1N1 flu vaccine manufacturers.

Besides IL-2 and squalene, nonoxynol-9—a spermicide determined to cause spontaneous abortions and birth defects—is an additional ingredient in some H1N1 flu vaccines.

## VACCINATION DOES NOT EQUAL IMMUNIZATION!

Words can be used to deceive.

For instance, “Immunization” does not mean “vaccination.” “Immunization” traditionally refers to a natural exposure to antigens, followed by a natural immune response, building lasting natural immunity. The word “vaccination,” alternatively, refers to a medical procedure that typically triggers hyper-sensitization reactions within the lymphatic system.

Another fraudulent myth is that the FDA tests vaccines and/or assures their safety and efficacy. This myth persists due to continuous reinforcement by the news media, controlled by the PFNYC trust, and advanced by brainwashed health officials that repeat this seductive mantra — “vaccines are safe and effective.”

More deception accompanies the myth that vaccinations are “mandatory” when, by Constitutional law, they shall be voluntary for all who honor religious prohibi-

tions and others philosophically-inclined to refuse vaccines since America has traditionally provided equal protection under the law.

lengths of time to secure certainty that vaccines are safe, and will not cause diseases, or premature deaths, months and years after inoculations.

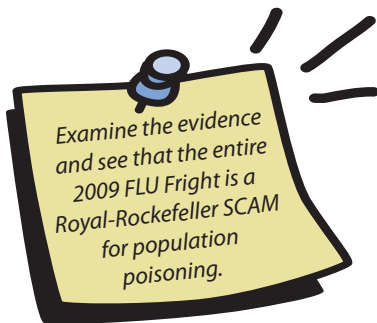
2) Federal reliance on safety studies and data exclusively provided by drug companies -- vaccine makers who have consistently manipulated data for profit.

13) Official malfeasance and neglect of 4th Amendment rights of people to be secure in their persons and houses, without threat of unwanted invasions of their bodies and properties.

14) Official malfeasance and neglect of people's 5th Amendment rights to secure life, liberty, or personal property, including their body sovereigns, and due process of law;

or risky medical interventions yielding further intoxications depopulating the group in whole or in part;

(f) imposing measures intended to prevent births within the group as has been documented in *Vaccine Weekly* (1995 May 29 - Jun 5:9-10) wherein it states:

"[T]etanus vaccines laced with hCG have been uncovered in the Philippines and in Nicaragua. In addition to the World Health Organization (WHO), other organizations involved in the development of an anti-fertility vaccine using hCG include the UN Population Fund, the UN Development Programme, the World Bank, the Population Council, the Rockefeller Foundation, the U.S.

National Institute of Child Health and Human Development, the All India Institute of Medical Sciences, and Uppsala, Helsinki, and Ohio State universities."
